Multiple Family Members: There is a 10% discount for 2nd child and a 15% discount for 3rd child. For three or more, contact the office for assistance.

Payment Options: Tuition Express (TE) is an automatic payment system using checking, debit, and credit accounts. All families must create a TE account through our ProCare System for all payments. If you do not arrange for automatic payment drafts, there will be a \$25 fee per month added to your regular payment. There will also be a \$25 fee to any change in dates with your TE account. If payment processed is denied, a \$45 NSF charge will be assessed along with a late fee of \$15 per day.
